#### NCA Credo for Ethical Communication

- We promote access to communication resources and opportunities as necessary to fulfill human potential and contribute to the well-being of families, communities, and society.
- We promote communication climates of caring and mutual understanding that respect the unique needs and characteristics of individual communicators.
- We condemn communication that degrades individuals and humanity through distortion, intimidation, coercion, and violence, and through the expression of intolerance and hatred.
- We are committed to the courageous expression of personal convictions in pursuit of fairness and justice.
- We advocate sharing information, opinions, and feelings when facing significant choices while also respecting privacy and confidentiality.
- We accept responsibility for the short- and long-term consequences for our own communication and expect the same of others.

So explains the purpose and mandate of the Academic and Student Rights Commission.

#### 4. **RATIFICATION OF NEW MEMBERS**

Be it resolved that Robert Fan, Rahul Lakhani and Hardarshan Kahlon be ratified as voting members of the Academic and Student Rights Commission for the 2013-2014 year.

#### **CARRIED**

#### **REVIEW OF COMMISSION PRIORITIES** 5.

#### **DISCUSSION**

So states that she would like to provide a background on the work that was done last year, and discuss how we can build upon it this year.

#### **Governance Reform**

So talks about last year's governance reforms, which severely cut the number of student seats at the highest decision making bodies at the Mississauga and the Scarborough campuses.

Sajjad states that changes were pushed through without student consultation.

Nehrin states that these changes did not take into account the needs of the east and west campuses.

Fan states that Governing Council does not meaningfully take student concerns and input into account.

#### **Drop Credit**

So explains the Drop Credit policy and talks about the discussion paper on Drop Credit policy that was released from the Union from last year. She circulates the "Moving Towards a Drop Credit Policy" discussion paper.

#### **Food Services**

So explains that last year the Canadian Federation of Students created a survey to evaluate the quality of food on campuses. She further states that we held two town halls to obtain further input from students. She states that we have submitted a FIPPA request to look into the food service providers contract between UofT and Chartwells. She states that the Union actively participated in the Food Advisory Committee.

#### **Access Copyright**

So explains the Access Copyright agreement with the university, and identifies why students do not actually need this service.

Fan states that Governing Council and the university administration continue to make decisions that do not necessarily reflect the will of students and we should discuss how to effectively lobby the university.

Sajjad states that we did achieve a small victory in that the university has stated their intent to reconsider the contract with Access Copyright, which expires in December.

#### **Ancillary Fees**

So states that the Union released a report last year examining illegal ancillary fees. She states that some examples are building access fees and I-clickers.

Sandeela asks whether these fees are illegal or just unethical.

Sajjad states that the Ministry of Training, Colleges and Universities released a policy document clarifying the guidelines on ancillary fees.

Fan asks about media attention on the ancillary fees issues.

Kahlon asks about the fairness of an opt-in system or an online opt-out system on levy groups. He states that opt-in fees would be fairer because many students do not know how to opt-out.

Nehrin states that a concern at UofT Scarborough is how to access downtown-centric services. She states that students on those campuses, for example, pay for Hart House.

So states that she will look into how to improve the website to make it more clear on listing the levy groups and that she will explore the options of an online opt-out system.

Fan asks for more information on the UTSU levy groups.

Sajjad states that more information can be found by coming into the office or checking the UTSU the website.

So states that the Union is also creating a new website and part of the process will be ensuring the levy groups are more visible.

#### 6. DISCUSSION OF COMMISSION PRIORITIES

#### **DISCUSSION**

#### **Drop Credit**

So states that a second discussion paper will be launched in September and it will be helpful to think of a plan on how to approach and educate our members.

Khan, O. enters the meeting at 13:20.

Kahul states that the new mark should count as a reflection of how much you learned. He states that that is what the employer cares about. He further states that previously people would drop courses if they felt that they would not do well.

Bollo-Kamara states that she would like to see a standardized drop credit policy.

Nehrin states that this is a tri-campus initiative. She states that there are irregularities across campuses.

#### **Per-Course Fees**

So states that the flat fee system is problematic. She states that it forces students to take a full course load or pay more to complete their degree. She states that she would like to bring this issue to the forefront during Orientation. She states that Trinity College Director Ben Coleman sent her an email suggesting ideas to link the campaign to other fair fee billing issues such as tuition deposits, per-semester billing, and interest charged on outstanding balances, but the Union has to plan out tactics and arguments in order to lobby to have this policy reversed.

Kahul states that about half of universities across Ontario have implemented flat fees due to funding constraints.

Sajjad states that very recently the provincial government created a moratorium on flat fees, and that no more universities can implement this fee structure. He further states that we should question the research that the university created on flat fees.

Nehrin states that we should challenge the myth that there is not enough funding at the university. She states that more money is being put into buildings as opposed to students.

So states that we should continue to work on this issue, that we should use all of the above arguments, work together, and gather information from members on their struggle under a flat fee system and so we can be stronger when proposing this case to the university.

Kahul states that he has definitely experienced the problems of flat fees. He states that it is a worthy initiative but he is not sure that it will work.

Sajjad states that we should work on testimonials from students, and that we should use the fact that the government agrees that flat fees should not existed to argue for UofT to discontinue their

use.

Kahul states that there was not enough support to deter flat fees last time, and that students' unions need to make sure students know about this issue.

#### **Illegal Ancillary Fees**

So states that we should look into creative ways to approach this issue. She states that some suggestions from Trinity College Director Ben Coleman were putting posters outside the UofT Bookstore about I-clickers and creating a system where students can report fees that they think may be illegal and to promote it at the beginning of the semester.

Kahul states that a major priority of this campaign should be awareness, and that we should be working to ensure that students know that they do not have to pay these fees.

Sajjad states that we should do research across universities and compare to UofT's reaction. He states that Windsor refunded fees that were illegally charged.

So states that she would like to do a teach-in section across different colleges and faculties to let them know about what fees they can and cannot be charged.

#### **Food Options**

So states that last year, students identified that they would like to see more food town halls as well as work with residences to look at quality of food.

Sajjad states that we should be getting in touch with residence councils to see how students feel about the food.

Kahul says that we need more halal, kosher and vegetarian options, but also things like more protein, for example, for students who work out. He further states that the food is overpriced compared to options available off campus, but meal plans are mandatory.

Lakhani asks whether meal plans are mandatory.

Bollo-Kamara states that facilities and policies vary across campus. She states that Woodsworth has full kitchens and does not require students to purchase meal plans.

So states that students' input will be used to generate a report for the university as to how we can improve food services at UofT.

#### **Academic Appeals Guide**

So states that appeal processes are difficult to navigate for students. She states that different colleges and faculties also have different procedures. She states that she wants to hear from students about the things they are most concerned about and what they need help with. She states that she would like to see the Academic Appeals Guide launch around January, when students have finished the first round of exams and first semester courses.

Kahul states that specific colleges have different policies and this should be more centralized.

So states that we can definitely work on this while creating the Academic Appeals Guide.

Sandeela exits the meeting at 13:33.

#### **Access Copyright**

So states that she wants to hear from members as to how we can encourage the university not to

re-sign the contract.

Bollo-Kamara suggests researching other universities who do not use Access Copyright.

#### **OHIP for International Students**

Kahul states that he is opposed to this campaign. He states that average wait times are very high and tens of thousands of international students would put further weight on the system. He states that stress on healthcare system will continue to worsen with current demographics. He further states that UHIP has its own issues, and that we should make it a requirement for international students to have to pay for health insurance elsewhere.

Sajjad states that international students contribute about \$2 billion dollars to the provincial economy.

Kahul states that our families pay taxes through their income and are essentially subsidizing it for our children.

Sajjad states that Canada actually depends on immigration and most international students stay in Canada and will continue to work and pay taxes.

So states that international students are here to contribute to the economy.

Kahul asks whether there are statistics on how many international students stay after their studies.

Fan states that as a students' union, we should fight for student rights. He states that we should invest in the future and they will give back.

Bollo-Kamara states that health care is a human right. She states that it also makes sense financially to support this initiative.

Kahul states that we should be concerned about the rest of people in the province who are students.

Lakhani states that OHIP for international students would help us to further recruit international students, which means more revenue for the University and contributions to the provincial economy.

Bollo-Kamara states that we should recognize that not everyone would be swayed by an ethical argument. She states that we do have statistics about the benefit of international students to our economy so we should follow up with research and facts to use them to make our campaign stronger.

Sajjad states that it is not necessarily the case that there is no public support for it. He states that when the provincial government created grants for international graduate students, there was public support for it and outcry against xenophobic arguments.

So states that Bilal Sandeela suggested that we work with professors, such as those from health economics, to build support for this initiative.




